Public Comments: Gary Finley stated that the same burning ordinance offender he spoke of last month from 113 Marshall Place was burning again on July 23<sup>rd</sup>. Finley stated that he had pictures showing that the resident was burning illegal construction materials such as vinyl siding. The fire was 5'-6' high, unattended and was burning outside permitted burning hours. The fire was also left to smolder for hours causing the entire surrounding area to be filled with terrible smelling smoke, which is also in violation of the burning ordinance. He said that a police officer was dispatched to the scene, but that the Hickory Township VFD never showed up. He wanted to know why the Hickory Township VFD is not doing their job putting out fires and citing offenders.
