The regular monthly meeting of the Hickory Township Board of Supervisors held at the Hickory Township Municipal Building was called to order at 7:00 p.m. by Chairman, Christopher J. Fabian.

Supervisor Hall made a motion to accept the January 6, 2025 reorganization and regular meeting minutes without correction. Motion was seconded by Supervisor Dean. All in favor. Motion carried.

The January Treasurer’s Report was read. Supervisor Dean made the motion to accept the Treasurer’s report and pay all regular, incoming bills and payroll. Motion was seconded by Supervisor Hall. All in favor. Motion carried.

**Old Business:** Supervisor Fabian made a motion to set the pay rate for seasonal CDL drivers at \$18.00/hr. Motion was seconded by Supervisor Hall. All in favor. Motion carried.

Supervisor Dean made a motion to set the Zoning and Code compensation at the flat rate of \$850.00/mo. Motion was seconded by Supervisor Fabian. All in favor. Motion carried.

**New Business:** The Final Plan of Subdivision and Lot Consolidation for Reiber/Abranovich was reviewed as submitted. Township awaits receipt of the signed DEP sewage module application packet from the SEO. The Hickory Township Planning Commission reviewed said Plan at their January 16, 2025 meeting and approved it pending receipt of the signed/approved DEP sewage module packet. Supervisor Fabian made the motion to approve said Plan contingent upon receipt of the signed DEP sewage module packet. Supervisor Dean seconded the motion. All in favor. Motion carried.

Supervisor Dean made the motion to pass Resolution #2025-4 authorizing Supervisor Fabian to sign the annual agreement with Infocon Corp. to prepare the 2025 real estate tax bills. Motion was seconded by Supervisor Fabian. All in favor. Motion carried.

Supervisor Hall made a motion to add a \$50.00 Township administrative fee to all permit and non-permit activities exhibited on the annual Sewage Enforcement Fees set by the Township SEO. Motion was seconded by Supervisor Fabian. All in favor. Motion carried.

Supervisor Hall made a motion to increase the Zoning Application fee to \$1,000.00 plus reimbursement of any engineering fees/costs incurred by the Township, if applicable. Motion was seconded by Supervisor Dean. All in favor. Motion carried.

Supervisor Hall made a motion to continue participation in the annual COSTARS Sodium Chloride Contract for period of August 2025 – July 2026 with an estimated salt order of 100 short tons. Motion was seconded by Supervisor Fabian. All in favor. Motion carried.

Supervisor Hall made the motion to adjourn the meeting at 7:14 P.M. Motion seconded by Supervisor Fabian. All in favor. Motion carried.
