Supervisor Hall made a motion to adopt Resolution 2022-13 authorizing the Township to submit an application seeking grant funds from the 2023 Lawrence County Transportation Improvement Grant Program for a 2023 Peterbilt dump truck and authorizing a signatory for said application. Motion was seconded by Supervisor Fabian. All in favor. Motion carried.

Supervisor Fabian made a motion to adopt Resolution 2022-14 authorizing the Township to submit an application seeking grant funds from the US Fish and Wildlife Fish Passage Funding Grant for the Devil’s Elbow Road culvert replacement project and authorizing a signatory for said application. Motion was seconded by Supervisor Dean. All in favor. Motion carried.

Supervisor Hall made a motion to adopt Resolution 2022-15 authorizing the Township to submit an application seeking grant funds from H2O PA / COVID-19 ARPA H2O PA Grant for the Devil’s Elbow Road culvert replacement project and authorizing a signatory for said application. Motion was seconded by Supervisor Fabian. All in favor. Motion carried.
